## Comprehension Questions on Talmud Shabbat 21b

1. According to the Sages in the <i>baraita</i> , how does one do the "basic" mitzvah of lighting Chanukah candles each day?
2. If you were doing the "basic" mitzvah of lighting Chanukah candles, how many candles would you light on the 6th night?
3. According to the Sages in the <i>baraita</i> , how does one do the " <i>mehadrin</i> " version of lighting Chanukah candles?
4. If you were doing the " <i>mehadrin</i> " <i>mitzvah</i> of lighting Chanukah candles, and there were 4 people in your household, how many candles would be lit on the 6th night?
5. Regarding the <i>mehadrin min hamehadrin</i> practice, whose opinion is mentioned first? Whose is second?
6. According to Beit Shammai, how many candles would you light on the 3rd night? And how many according to Beit Hillel?



7. According to Ulla, what were the <i>Amoraim</i> in <i>Eretz Yisrael</i> arguing about?
8. Explain the reasoning for Beit Shammai's position:

6. How does this Gemara connect with the Gemara in <i>Shabbat</i> 21b regarding how we light Chanukah candles?

5. How does <i>Malbim</i> 's explanation clarify the inconsistency in the Mishnah?

1. Despite significant differences in opinion regarding <i>halakha</i> , what did the communities of Beit Shammai and Beit Hillel continue to do?
2. Which group is mentioned first in the Gemara?
3. How did the two groups behave towards one another?
4. What guided them in their behavior?
5. What does the <i>pasuk</i> from <i>Zechariah</i> tell us to do?
